

HOLLANDSE CLUB

SOCIAL MEMBERSHIP TERMS & CONDITIONS

General

- Social Membership, is available to Residents of Singapore of twenty-one (21) years of age or older, provided the individual or family has purchased in due form Social Membership from the Club.
- The applicant shall complete all forms: Membership Application Form with photos of family members who are 11 years old and above, signed Terms & Conditions and an original copy of the GIRO form.
- Membership shall commence from the payment date of the membership fee or the indicated start date upon payment. Commencement date is the effective date of monthly subscription fee prorated during the first month and billed in advance for the subsequent months.
- Membership period is for a minimum of one (1) year, to be calculated from the day of the activation of the Membership.
- Social Membership shall be automatically renewed monthly b a s i s after the completion of the first one (1) year period.
- During the first year of membership, members are not eligible to downgrade from their current membership type.

Rights & Benefits

- A Social Member has no voting rights within the Club.
- Social Membership is not transferable.
- A Social Member enjoys full access to the Club's facilities and amenities, including participation in the Club's events and classes at member's rates.
- A Social Member has full access to the Reciprocal Clubs.
- Guests may be introduced in accordance with the Club's guest policy. All members are required to register their guests at Reception on entry to the Club, and to pay the appropriate fee.

Payment

- Each month a subscription fee of SGD \$205 (for singles) or SGD \$386 (for couple/families) is required.
- A one-time refundable deposit of SGD \$700 (for singles) or SGD \$1000 (for couples/families) is payable before the start of membership unless the appropriate deposit is already held by the Club. This deposit will be returned post settlement of subscription fees of the remaining months.
- A one-time joining fee of SGD \$450 is payable before the start of the Membership if new Members to the Club.

Diplomatic Clause

- In the event a Member will relocate for a diplomatic reason within the one (1) year term, the Member may terminate the Membership after a minimum of six (6) months giving a one (1) month notice period, without incurring a penalty hereunder.
- If a Member is required to relocate from the Hollandse Club within the first 180 days, they shall be obliged to pay the monthly subscription fees for the remaining months (of the first 180 days) and all other debts due, within one (1) week from written notice of resignation.

Dues & Suspension

- The Club reserves the right to suspend a Member's account if membership dues are not paid after a grace period of 2 months from the due date.
- A late payment fee of 1.5% will be imposed on overdue amounts.
- The defaulting Member will be denied admittance to the building and territory of the club till the full payment is completed before the fixed Ultimate Date
- To regain access and reinstate membership privileges, the defaulting Member must settle the outstanding dues in full before the fixed Ultimate Date of Payment. Failure to do so will result in the cessation of membership.
- If the Default Member is within the contract period, they shall be obliged to pay the monthly subscription fees for the remaining contract period and all other debts due.
- The Club reserves the right to take appropriate actions to recover the outstanding debt, including legal remedies as deemed necessary.
- All fees, including but not limited to legal fees, collection agency fees, or any other costs incurred in the recovery of debts, will be the responsibility of the defaulting member. The Club shall not be held liable for any such fees associated with the recovery process.

Resignation

- If the Member resigns from the Hollandse Club within the first year, they shall be obliged to pay the monthly subscription fees of the remaining months and all other debts due within one (1) week from written notice of resignation.
- After completion of the first-year term, the Member may cancel their Membership at any time by giving a written notice thereof to the Hollandse Club's secretariat.
- Advance 30 days' notice is required. This notice commences from the date when the Club receives the Member's resignation form, subject to Article 24 of the Club's Rules & Regulations.
- At the end of the Membership period the Hollandse Club will be entitled, without giving any prior written notice, to compensate for any outstanding sums due to the Hollandse Club with the refundable deposit referred to above. In case the sums due to the Hollandse Club exceed the amount of the refundable deposit, the Hollandse Club will maintain its rights to claim such balance.
- After the Membership has resigned, access to and usage of the facilities of the Hollandse Club is no longer allowed once the 30 days has expired.

Further to the above stated Terms & Conditions, Social Membership is subject to the Hollandse Club's Rules & Regulations and Bye-Laws and any further amendments thereof.
